## EUROPEAN VALUES IN THE PROCESS OF TEACHING THE DISCIPLINE «INTERNATIONAL ORGANIZATIONS»

European integration is Ukraine's close cooperation with the European Union at the level of laws, rules, norms and customs existing in international society. European integration reflects the desire of each society for a new worldview, including responsibility, respect for each other, tolerance and the desire for intercultural dialogue. European integration processes in the context of high-quality university education are characterized by systemic changes through reforms aimed at creating a system of ensuring and continuous improvement of the quality of higher education that meets the recommendations and standards of the European Education Area. International organizations have demonstrated political solidarity and support for Ukraine and condemned russian aggression through the process of political and diplomatic isolation and the introduction of large-scale restrictions on the aggressor in their structures. At the same time, establishing communication links between Ukraine and international organizations and partner countries is of particular importance for intensifying cooperation. Relations between Ukraine and the EU have their own peculiarities, including close interaction and cooperation in the direction of the EU-Ukraine Association Agreement on the establishment of a free trade area (abolition of import duties, harmonization of Ukrainian norms, procedures and regulations with European standards, creation of favorable conditions for access to European service markets), European support for the development of Ukrainian small and medium-sized enterprises (preferential loans, microfinancing, grants and educational programs, training of entrepreneurs in financial literacy); ensuring sectoral diversification of domestic exports; signing the ACAA Agreement (requirements of Ukrainian technical regulations for products to EU directives, Ukrainian producers will be entitled to apply the European CE mark of conformity to their products), etc.

The main business associations in the EU with which Ukraine cooperates are the Confederation of European Business, the European Federation of Chambers of Commerce and Industry, the European Wholesale and Retail Trade Association, and the Association of Small and Medium-sized Businesses. At the same time, there are dangerous situations for Ukraine in the process of European integration, first of all, the risk of our country's involvement in globalization conflicts and threats, the problems of illegal

migration and outflow of personnel, the influence of the EU's political influence on Ukraine's foreign and national economic policy and the complexity of its transition to the European regime. After all, these factors affected the export of goods to the EU, which decreased by 16.1% and amounted to 23,4 milliards US dollars. At the same time, imports of goods increased by almost 20,5% and amounted to 32,5 milliards US dollars. The imports of goods increased by almost 5% and amounted to 32,5 billion us dollars. Accordingly, the bilateral trade balance for Ukraine and the EU is negative and amounts to -9,1 milliards USD. The balance of bilateral trade between Ukraine and the EU will be negative and amount to USD 9,1 milliards in 2023.

The discipline «International Organizations» covers aspects of modern economic thinking and a set of specialized knowledge about the creation and functioning of international organizations, their role in the system of international relations, structural features and mechanisms of activity. Particular attention is paid to the analysis of the current state of international organizations, their impact on global processes and the prospects for integration and participation of Ukraine in their activities. Teaching the discipline involves the development of views on modern models of formation of systems of formation and development of international organizations, regulation of international relations and prospects for their development, study of the state of international economic, political and social integration, implementation of mechanisms of influence of international organizations on the process of globalization of the world economy, identify rational forms and outline the sequence of stages of Ukraine's participation in international organizations, evaluate their achievements, determine the prospects for cooperation between Ukraine is actively involved in shaping the political and economic environment in the international arena by being a partner of many influential international organizations, within which it is actively working, which, moreover, reflects the national interests of our country, which is an indicator of Ukraine's growing authority in the world.

Reflecting European values in teaching the discipline «International Organizations» allows not only to deepen students' understanding of the specifics of the functioning of international organizations as important actors in the global political and economic system, but also contributes to the formation of highly qualified specialists in international political and economic relations who are able to solve complex specialized tasks and practical problems of international cooperation, develop mechanisms of interaction between states and international organizations based on the national interests of the country.
