## EDUCATIONAL PRACTICE «INTRODUCTION TO THE SPECIALTY AND ACADEMIC INTEGRITY» FOR STUDENTS OF SPECIALTY 292 «INTERNATIONAL ECONOMIC RELATIONS» AND ITS EFFECTIVENESS IN THE CONTEXT OF EUROPEAN INTEGRATION
